The meeting of the Board of Trustees of the Village of Avon was held in the Whitney Room of the Village Hall, 74 Genesee Street, Avon, New York on Monday, May 16, 2016.

Mayor Freeman called the meeting to order at 6:00 P.M., and began the meeting with the Pledge of Allegiance.

JEAN SCHOENTHAL:

Resident Jean Schoenthal was in attendance to express a concern to the Village Board. She noticed that a large commercial bus had been parked in a resident's driveway, and she wanted to make sure that the Village Board hadn't changed the stand that businesses out of a home were not allowed. She says that there is a downtown district in the Village that is for businesses that should be utilized, not residential neighborhoods. Mayor Freeman adamantly responded that there has been no change, business should be in the downtown district. Mayor Freeman asked if Tony Cappello would reach out to the bus owner to discuss options.

DPW UPDATE:

Superintendent Barrett was in attendance to update the Board on the following:

- New Truck- The dump truck is on the road. The plow equipment has been removed and there is no logo on the truck.
- The sewer line on Dooer that has been collapsing is repaired.
- The crew has been doing a lot of cleaning up around the Village. They have been top soiling the tree stumps, picking up brush, cleaned the area behind Forsythe;s property, cleaned the ditch line at Neth's- there is a section of gutter that still needs repairing. The paver is being prepared with a new screen being installed.

- The Parks are looking good! Students from the high school will be participating in a "Day Of Caring", in which they will be helping with clean up and mulching. Mayor Freeman asked about the grant funding for the Parks, to which trustee Zhe replied that we shouldn't plan on it for this year.
- WWTP- Things are going well. The phosphorous numbers are in the range that they should be. Maintaining these numbers will be top priority during the construction at the WWTP.
- There was a brief discussion about sidewalks in the downtown district, however, the discussion was tabled and will be revisited at a later date.
- PESH- Bill Wall has been contacted to do the repair work required. Superintendent Barrett still needs to create a written program regarding workplace violence and other policies that should be reviewed yearly with his crew.

MRB UPDATE:

Kurt Rappazzo was in attendance to update the Board on the following:

- WWTP Bids- There have been 15 bid sets requested as of 5-16-2016. The bidding will be held on May 24th, 2016 at 2pm in the Village Hall.
- Sewer Use Law- the revisions have been sent to the DEC. Once approved, the Village Board has 3 months to adopt it. Kraft should be receiving their comments on the Sewer Use Law by June 1st, 2016. Barilla feels they should be ok with their load allotments.
- I&I- According to MRB, there has not been enough wet weather at the appropriate time (between 1am and 3am) in order to do the study. They are still waiting.
- Pole Bridge Road- Superintendent Barrett has been givin the pipe size to be used for the area around Gilmores property, and the existing infrastructure will remain as is. However, the project cannot move forward until funding has been locked in.
- MRB presented the Village Board with a draft proposal for the Lake Road/ Oak Hill project starting at Anderson Meadows Pond. The Mayor said that the Board would get back to them.

POLICE UPDATE:

Chief Benedict was in attendance and updated the Board on the following:

- There is a new memo of understanding for the Drug Task Force. The Sheriff will be contacting the Village.
- Officer Bruckel has completed his training.
- The new numbers and street name for the Tops Plaza was in effect as of the beginning of May.
- The speed sign has been set up on Genesee Street for testing, and has been around the Village. The sign is Bluetooth capable and will be able to sync with the laptop without having to plug directly into it. The sign only tracks oncoming traffic. The sign is also solar powered, however, there is a plug for charging.

CODE ENFORCEMENT UPDATE:

Tony Cappello gave an update on the following:

- There was a crew working on Cemetery Hill to clean up the corner property. The fence has been put up, and there has been a lot of things loaded up in front of the house. He didn't need to appear in court regarding the property. However, he will reach out to Village Court Clerk Jan Cole what the outcome was.
- A permit was issued for a fence and shed on River Street. When Tony went for the inspection, the measurements were incorrect. It has been corrected.
- Everything is in place for the new build on North Avenue. Superintendent Barrett will look at the drainage pipe on the property to see if it can be extended. The build should be complete by July 1st, 2016.

• Designation of Section 3 Coordinator:

RESOLUTION

WHEREAS, the United States Congress passed the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u ("Section 3"), and

WHEREAS, the purpose of "Section 3" is to ensure that employment and other economic opportunities generated by certain federal assistance, including assistance provided by the U.S. Department of Housing and Urban Development (HUD) or HUD-assisted projects covered by Section 3, shall, to the greatest extent feasible, be directed to low- and very low-income persons, particularly persons who are recipients of HUD

assistance for housing, and

WHEREAS, the Village of Avon is currently and anticipates it will continue in the future to be a recipient of certain HUD assistance covered by Section 3, and

WHEREAS, HUD and the administrative entity of HUD's Small Cities Program in the State of New York, the Housing Trust Fund Corporation, have determined that Community Development Block Grant grantees must designate a municipal employee to serve as the Section 3 Coordinator to facilitate compliance with Section 3, and

WHEREAS, it will be the job of the Section 3 Coordinator to prepare, implement and undertaken certain plans and procedures to facilitate compliance with Section 3 to the greatest extent feasible,

NOW, THEREFORE, BE IT RESOLVED that the Village of Avon Board of Trustees does hereby designate Heather Randall, Village Clerk, and his/her successor, Christine Quinlan, Treasurer, at such time Heather Randall no longer serves in the capacity of Village Clerk, as the Section 3 Coordinator.
