APPLICATION FOR SWIMMING POOL PERMIT

Instructions

- a. This application must be completely filled in by typewriter or in ink and submitted in duplicate to the Village Clerk's Office.
- b. On back of this application, draw a plot plan showing location of swimming pool and of building on premises, relationship to adjoining premises or public streets or areas, and give a detailed description of layout of property, which must be drawn on the diagram which is part of this application.
- c. This application must be accompanied by two complete sets of plans showing proposed construction. Plans shall describe the nature of the work to be performed, detail of pool structure, mechanical, electrical, and drainage installations.
- d. The work covered by this application may not be commenced before issuance of Pool Permit.
- e. Upon approval of this application, the Building Department, will issue a Swimming Pool Permit to the applicant together with approved set of plans and specifications. Such permit and approved plans and specifications shall be kept on the premises available for inspection throughout the progress of work.
- f. The Building Inspector shall have the right to enter upon the premises for the purpose of inspection and construction covered by this application at any time during the construction period without notice.
- g. The Swimming Pool shall not be used for any purpose whatever until a Certificate of Approval has been granted by the Building Department.
- h. All wiring must be inspected by N.Y.S. Underwriters Inspector. All wires and fixtures must be exposed for preliminary inspection. Power Co. must be contacted for application.
- i. Contact Village Office for inspection when (1) pool is staked out, (2) at time water is being put into pool, and (3) when work is complete. Allow 24 hrs. for inspection.
- j. To Owners: As a home owner you are completely responsible for this permit. Read the Swimming Pool Ordinance. Read your Permit. Your contractor can not be held liable by the Village of Avon. The Building Inspector will not be held responsible for any infraction of the pool ordinance or this permit.
