The meeting of the Board of Trustees of the Village of Avon was held in The Whitney Room of Village Hall, 74 Genesee Street, Avon, New York on Monday February 3, 2020.

Mayor Freeman called the meeting to order at 6:00pm and began with the Pledge of Allegiance.

### VICKI ROSE: LITTLE FREE LIBRARY

Mrs. Rose presented the Board with a proposal for a Little Free Library she would like to create for her neighborhood. Little Free Library is a way to bring books and neighbors together. The "library" is an area created with a box/container that houses a small quantity of books. Those who live in the neighborhood can borrow a book or bring a book to keep the collection fresh. The container itself can be made from anything and can be any form. It would be registered with the Little Free Library Organization, which is a nationwide organization. Mrs. Rose asked for permission to put it across the street from her home. She is able to see it from her house and is willing to maintain it. She has already received permission from the Avon Commons office, who stated they thought it was a wonderful idea. She would like to have everything set for Memorial Day. The Board agreed that they thought it was a wonderful idea for the neighborhood and is happy to encourage Mrs. Rose to move forward with the project. Supt. Barrett said he would be willing to help dig the hole for the post. He just needs a lead time of 10 days in order to call in a stakeout.

#### **DPW UPDATE:**

Supt. Barrett provided the following update:

- Tree trimming through the Village
- Worked on the remediation report for the Army Engineering Corp. He is waiting for comments back.
- Met with MRB to discuss the Pump House. If the footprint is made smaller, a precast building could be used, which could save approximately \$150k. MRB would like to get an engineering proposal to the Board. The schedule as of right now looks to be engineering in spring/summer 2020, bidding in the fall 2020 with construction in 2021. The old building will be kept in service until the new building is complete, and then transfer service over. This is more efficient due to the layout, the efficient pumps and

motors. Everything will be constructed for what is needed rather than making add-ons and adjusting to fix the need.

- Next two weeks-working on the "high priority "take down of the trees based on the management plan and Dr. Luley. Then they will work on the "high priority" trims continuing as Dr. Luley suggested with the "moderate priority" trees. Two large trees have come down, one by the Avon Inn and one by St. Agnes. The Bur Oak it the Downs will be looked at on Wednesday.
- Took a tour with Trustee Zhe and Parks Chairman John Marks of restrooms in local parks as part of the GVBA Grant to install restrooms at the Downs. The restrooms at the Geneseo Village Park was best suited to what the Village is looking for. Supt. Barrett thinks that there should be provisions made for heating in the restroom, keep the hardware simple, make sure there are changing tables. Looking at about a 20 x 24 size building.
- Supt. Barrett reviewed the conference call held with National Grid re: our purchase of the light inventory in order to move forward with our Lighting Project with NYPA. National Grid has found an "anomaly" in the Net Book Value (NBV). The calculation is being reviewed and will be sent to the public service commission when corrected. It appears that this will take some time. Supt. Barrett, at the Board's request will reach out to see if NYPA can start the project with the lights that the Village already owns. However, Supt. Barrett said that NYPA initially didn't want to piece meal the project together. They were hoping to take care of all the lights in 2 days. He will ask if the possibility is there.

That copies of the Sewer Use Law shall be made available to the public at the Village office.
