- Supt. Barrett will provide a list of future projects for review either electronically or next meeting. He also hopes to have the schedule c numbers for the Boards review at the next meeting. The Water Board will be meeting in April.
- Received a request for sewer capacity allotment in the industrial park in East Avon from the U of R. The anticipated flow should be within the available capacity. Supt. Barrett reviewed the request along with MRB and feels confident that it will impact our plant minimally. Supt. Barrett and MRB will prepare a letter stating that the request is accepted.
- Two project updates: 1. Epoxy floor at the WWTP. Received a quote from C.A. Reed in the amount of \$27,931. This is a commercial grade company. Supt. Barrett called other companies for quotes; however, C.A. Reed are the only commercial grade in the area. This project was budgeted previously and already went through the permissive referendum requirement.

MRB UPDATE:

Bill Davis provided the following update to the Board:

- Sewer Collection I & I project- Final report was submitted to EFC for approval for remaining grant funds. Approval was granted. Improvements to be budgeted by the Village for 2020. Will verify with Treasurer Quinlan of receipt of funds.
- WWTP Disinfection Requirement- WQIP grant not received by the Village in 2019. MRB suggests to re-apply in 2020. Because of DEC's compliance schedule, the Village will need an extension or should consider starting the design phase in 2020.
- Pebble Beach Pump Station-MRB has developed a more detailed site drawing, with pump selection, building lay-out, and hydraulic profile to refine cost estimate. Cost estimate has been provided for both a CMU building and a prefabricated steel building.
- Water Tank Study-MRB is prepared to present a final report to the Village and Town. Meeting is to be determined.
- Route 5 & 20 Culvert Replacement- Village and Town are working together to continue developing this project. Looking to apply for the Bridge NY grant again.
- Parking Lot Joint Project- Village and Town are working on a concept and determine where funding will be coming from. MRB has looked at access to the lot and potential improvements. MRB has also provided some entrance ideas. Entering the lot from Genesee Street has also been discussed.
- SIU Permit with Kraft- Working with new management at Kraft in review and finalization of the permit.

CODE ENFORCEMENT UPDATE:

Zoning Officer Cappello offered the following update to the Board:

- Demolition has started in the Park Theater. Tony will check to see how long the dumpster is supposed to be there. He will remind them it needs to be removed for the parade.
- There has been no contact with Mrs. D'Angelo regarding the sidewalks in D'Angelo Parkway. Mayor Freeman suggested we help her out by locating a contractor for her to speak with.
- Houses by Barilla have been demolished.
