Jim also stated that the timeframe for obtaining a permit and build out is unrealistic in our current solar law and that has been amended in our drafted solar law currently being reviewed. He stated the new law if approved will double the time for obtaining a building permit from 6 months to one year and for build out from 12 months to 24 months.

Jeff Mulligan stated he feels this seems simple enough.

Kathy Cole agrees with the extension due to COVID causing delays.

Brian Thorn asked if a one-month extension is realistic for them to get all the paperwork submitted to us.

Jim Campbell asked Michelle Piasecki, Attorney for DG Solar, if that is ample time for the applicant to get all the paperwork submitted. Ms. Piasecki thanked everyone for holding this meeting so quickly. She stated there are only a few documents and issuance of the bond left to submit before the permit can be issued. She feels granting a one-month extension will be plenty of time for them to get in the paperwork.

Jim Campbell stated that he has been in contact with Lance on what needs to be completed and they both feel that will be sufficient for them to submit the paperwork.

Cindy Kellen wondered if the neighbors will be upset because we did not advertise this meeting.

Jim Campbell stated we posted it on the website and sent it to the paper as an emergency meeting which does not require a public hearing.

Jim Campbell stated that he would like each Board to make separate motions and approvals on the one-month extension.
