BARRESI, CHUCK/PRO-MECH LEARNING SYSTEM/2979 LAKEVILLED ROAD/TAX MAP PARCEL#55.-1-78.1/EXPANSION OF TRAINING CLASSES.

Mr. Barresi is looking to expand his training classes to train drivers and they have partnered with PDI. Ms. Kelly Phalen from PDI was present as well. Mr. Barresi & Ms. Phalen's hope is to have 6-12 students a month no more than 24 students. The hours of operation will be similar to what they are currently operating, however they would like to add these additional hours 6-10PM and Saturday. PDI is currently located in Churchville. Mr. Barresi is testing out the partnership in the hopes of a merger next year. The road training is a one month class where they would be driving in Avon, Henrietta and downtown Rochester. There will be no change to the approved site plan, however they will be building a wooden dock for the trailers to bump as part of their training.

There will be additional vehicles on premises but not all will be in use at the same time. Brian Glise stated one of the contingencies of the originally approved Special Use Permit with Silvarole was the parking lot had to be paved to eliminate dust. The parking lot was treated with calcium instead of being paved and that was acceptable with the Board. There are 9 full time employees and 3 of the employees travel continuously. Brian stated that you need to have 1 parking space for every 200 square feet of floor area. The building is less than 9,000 square feet and there is plenty of space to add parking spots.

They will need to change/add the sign but are not sure exactly what they want to do yet. Brian stated code allows 2 signs that do not exceed 120 square feet. Mr. Barresi will get information on the signage and make sure it is within the Town code regulations.

Jeff & Cindy stated a public hearing will be needed for the variances of additional hours, sign and parking lot requirements. Kim will research to find out exactly what the facility was approved for previously to determine what variances are needed. Cindy stated we can do all variances at one public hearing. Jeff determined the public hearing will be at our May 21, 2018 meeting. Kim will get in touch with Mr. Barresi for the next steps in the process.
